

## Northrop Grumman Selects Virginia for New Corporate Office

## Move will bring company leaders closer to federal government, key customers

LOS ANGELES, April 26, 2010 /PRNewswire via COMTEX/ --Northrop Grumman Corporation (NYSE: NOC), announced that it will locate its new corporate office in Virginia, concluding a search that also included the state of Maryland and the District of Columbia.

"We are pleased to have identified Virginia as the home for our new corporate office. Virginia, Maryland and the District put forward compelling, competitive offers. Our final decision was driven largely by facility considerations, proximity to our customers, and overall economics," said Wes Bush, chief executive officer and president. "We are very appreciative for the tremendous assistance we received from Governor O'Malley and the State of Maryland, Mayor Fenty and the District of Columbia, and Governor McDonnell and the Commonwealth of Virginia as well many local counties and municipalities."

Northrop Grumman is currently conducting negotiations with several building owners in the Falls Church/Arlington area, with a specific building selection to be announced soon. The company expects to initiate operations in the new corporate office in summer of 2011 with approximately 300 people. Northrop Grumman currently employs approximately 40,000 people in Maryland, Virginia and Washington, D.C. and is the largest industrial employer in both states.

"The foremost priority of our Administration is creating new jobs and getting our economy back on track," said Virginia Governor Bob McDonnell.
"Today's announcement that Northrop Grumman, a Fortune 100 company, is moving to Virginia is a major step forward in this effort. Northrop
Grumman and the Commonwealth of Virginia have long shared a close and positive working relationship. To gain the corporate headquarters of one of
the largest defense and global security contractors in the world is a testament to the strong business climate that we are focused on continually
improving. This Administration will keep taxes and regulations and litigation at a minimum to attract job creators from around the world to our state to
ensure more new opportunities for all Virginians. I welcome Northrop Grumman to Virginia. I know the company will be a great corporate citizen and
partner, and I thank Wes Bush and his team for their investment in the future of Virginia."

"We were fortunate to have so many great choices in this region, where Northrop Grumman has such an extensive business base," Bush said. "We are grateful to Senators Mark Warner and Jim Webb of Virginia, House Minority Whip Eric Cantor, Congressman Jim Moran, Senators Barbara Mikulski and Ben Cardin of Maryland, Majority Leader Steny Hoyer and the entire congressional delegations of both states for their strong and continued support of the defense industrial base and job creation that is critical to the economic success of the Mid-Atlantic region."

Following the move of the corporate office, Northrop Grumman will remain the largest aerospace company in California with approximately 30,000 employees. Its Aerospace Systems sector is headquartered in Los Angeles County, and each of the company's other four sectors have major facilities in the state. "Northrop Grumman is proud of its longstanding involvement with Los Angeles," Bush said, "We will continue to have a strong commitment to Los Angeles and the region and look forward to working with them for many years."
